## IMPORTANT INFORMATION REGARDING THE PROMINENCE ENERGY LTD GENERAL MEETING

All resolutions will be decided by a poll. The poll will be conducted based on votes submitted by proxy and at the Meeting by shareholders who have indicated that they intend to vote at the Meeting in accordance with instructions set out below.
